**IDENTITY THEFT**

Inver Grove Heights Police Department attempted to stop a vehicle in the area of Cahill Avenue and 70th Street East. The vehicle fled from officers. The suspect vehicle was found by officers and followed while not re-engaging in a pursuit. The Minnesota State Patrol helicopter followed the suspect vehicle and gave updates to officers so stop sticks could be deployed. The suspect vehicle crashed into another vehicle at Highway 62 and Delaware Avenue. The crash occurred at a high rate of speed resulting in an additional collision with a parked Minnesota State Patrol squad car that was trying to deploy stop sticks. The Minnesota State Patrol Trooper was not injured. Both occupants were transported to a local hospital due to their injuries.
