### **CRISIS**

### **9/8/25, 1530 HOURS, DOUGLAS RD/VICTORIA RD**

### **PD ACCIDENT**

Unit 1 was traveling westbound on Douglas Road approaching Victoria Road when they failed to stop at a posted stop sign. Once in the intersection, Unit 2, which was traveling south on Victoria Road towards Douglas Road collided with Unit 1 in the front passenger side tire. After the initial collision, Unit 2 was partially dragged by Unit 1 causing damage to the entire driver's side of Unit 2 and partial damage to the passenger side of Unit 1. Unit 2 did not have a stop sign and had the right of way. Both vehicles had disabling damage and were towed. Driver 2 was evaluated by medics, but was not transported to the hospital. Driver of Unit 1 admitted to not seeing the stop sign and causing the collision with Unit 2. Driver of Unit 1 was cited for failing to stop at a posted stop sign.

### **9/9/25, 0629 HOURS, GLEN TORO RD**

### **PD ACCIDENT**

Unit 1, a garbage truck, had stopped with its 4-way lights on, on Huber Drive to pick up trash. Unit 1 collected the trash and began moving again with its flashing lights to turn left onto Glen Toro Road. As unit 1 began to turn left, unit 2 had started to attempt to pass unit 1 in the left lane of opposing traffic. It should be noted that Unit 2 had a solid yellow line that indicated this section of the roadway was a no-passing zone. Unit 1 continued to make its turn, and its front left bumper collided with the side of unit 2. Neither driver was injured and neither vehicle was towed. A CVI was called to inspect the damage to unit 1, as it is a commercial vehicle.

### **CRISIS**

Officer responded to the 700 block of South Plaza Drive for a report of a female in crisis. Female was placed on a transportation hold and was transported to the hospital.
